ELECTRICITY TARIFFS 2021/22


1. Introduction

The National Energy Regulator of South Africa (NERSA) is a regulatory authority established as a juristic person in terms of Section 3 of the National Energy Regulator Act, 2004 (Act No. of 2004) to regulate electricity , in terms of the Electricity Regulator Act (ERA) (Act No. of 2006). In accordance with the provision of Section 15 (1) of ERA Licenses are required for the increase of electricity tariffs.

2. Adjustment

Taking into consideration the NERSA benchmark guidelines proposing 14,59% increase, the tariffs for the 2021/22 financial year were increased as per attached annexure A. Notwithstanding the benchmark guidelines, the municipality applied an increase commensurate to the wide variety of tariffs which supports sustainability of providing the service by the municipality. As much as the increase in most tariffs was within the benchmark guidelines, there were a few that were slightly above.
